Renew EP (excluding Sponsorship scheme), S Pass, Dependant's Pass (except dependants of Personalised Employment Pass), Long Term Visit Pass and Letter of Consent. Upload relevant supporting documents for a work pass or related pass application. Appeal for rejected applications. Check application and renewal status. Issue EP, S Pass and related passes.

### Employment Pass - Ministry of Manpower Singapore

Only eligible candidates will be considered for an Employment Pass. Criteria include a minimum salary of \$4,500 and acceptable qualifications. Use the Self-Assessment Tool to check a candidate's eligibility before you apply.

### Eligibility for Employment Pass

You need to submit documents such as copies of passport details and birth or marriage certificates along with the Dependant's Pass application. You will need these documents to apply for a Dependant's Pass ( DP ): Copy of the personal particulars page of the candidate's passport.

### Documents required for Dependant's Pass

Submit an application. Processing time for Dependant's Pass holder, within 3 weeks for most cases. For LTVP or LTVP+, 1 week. Some cases will take more time. To submit an application: Get a written consent to apply for the LOC from the candidate. Log in to EP Online to fill out the application and upload the required documents.

### Apply for a Letter of Consent - Ministry of Manpower

Dependants of Employment Pass and S Pass holders. Processing time: within 3 weeks. Some cases will take more time. To submit an application: Log in to EP Online to fill up the application and upload the required documents. Pay \$105 fee for each application. You can pay by GIRO, VISA, MasterCard or eNets Debit. Check your application status ...

### Apply for a Dependant's Pass - Ministry of Manpower

When your employer applies for the Employment Pass, they must submit the following supporting documents: Employment Pass application form. Passport size picture of you, in line with Malaysia photo requirements. A copy of your passport.

### Malaysia Employment Pass - Application and Requirements

Companies regulated by an Approving Agency must submit an approval letter from the relevant agency for each EP application (this includes EP Category I, II and III). Companies regulated by the Regulatory Body, they will be required to submit a letter for each EP application (for Category I, II and III).

The EP can only be processed by an employer, thus you will need to have secured a job in Singapore before moving to Singapore. Take note of the documents required for the Singapore EP application, which includes copies of passport details, and educational certificates. It may be handy to keep an electronic copy of these with you at all times.

Your employer logs in EP Online and fills out the S Pass Application Form. They attach all the documents required for the S Pass which are stated on the S Pass Application Form (see a list of the required documents below). They pay the S Pass application processing fee (S\$75).
