The law associated with this area of our program is the Kansas Pesticide Law.. We certify private and commercial applicators to use pesticides. To qualify for certification, a commercial pesticide applicator must show adequate knowledge of the type of pesticide application that he or she intends to perform.

The test to become certified as a Private Pesticide Applicator is open book and can be taken at any Kansas County Extension Office. The test normally takes two to three hours to complete. We recommend reading the manual before taking the test. Private Pesticide Applicator Manual (pdf) Restricted Use Pesticides. A private pesticide applicator license is required for purchasing restricted use pesticides.

As a private applicator you must complete the application procedure prescribed by the Kansas State Department of Agriculture, pass an examination, and pay fees. Under the Kansas Pesticide Law, the Private Applicator certification period is five years and expires on the applicator's birth date of the fifth year.
